

Cannelton Terquasquicentennial (175th) Logo Design Contest Entry Form

Deadline for all entries is 5:00 p.m. on Tuesday, October 25, 2011.

In 2012 Cannelton will be celebrating it's 175th birthday. The Cannelton Foundation, Inc. is sponsoring a "Design the Cannelton Terquasquicentennial (175th) Logo" contest for a logo to be used for the celebration.

CONTEST RULES & REGULATIONS:

- Anyone is eligible to enter the contest.
- There is no fee to enter the contest.
- All aspects of artwork must be completely your own. Absolutely no copying of existing material or ideas shall be permitted. By applying, you consent that you have not plagiarized any aspect of the design or artwork.
- Upon entering the contest you relinquish all rights to the winning logo. The winning entry becomes the exclusive property of The Cannelton Foundation, Inc.
- Artists may submit an unlimited number of entries.
- No monetary award will be given for the winning entry.
- Designs submitted for the contest will not be returned. All submissions must be delivered to 321 Washington Street, Cannelton, IN by 5:00 p.m. on Tuesday, October 25, 2011.
- All eligible entries will be viewed and voted on at the next meeting of The Cannelton Foundation, Inc. board and committee members.

ENTRY GUIDELINES

- The logo should convey elements of Cannelton's history.
- Designs must contain the location "Cannelton, Indiana", the years "1837 - 2012", and "Terquasquicentennial".
- Include your name, address and telephone number but do not sign your entry.
- Preferred file format is .JPG or .PDF at 300 dpi resolution. If you do not create your logo electronically, a hard copy may be delivered to 321 Washington Street, Cannelton, IN 47520.
- Attach this signed form with your submission.
- The winning logo will be used online, in print and on merchandise.

IMPORTANT PLEASE READ:

By submitting your entry, you agree to waive all compensation, present and future. You agree to allow your artwork to be duplicated and or distributed and or modified without notice.

You further agree to designate The Cannelton Foundation, Inc. as the owner of the artwork. The artwork shall not be submitted to any other contest or used for any other purpose. Submission implies complete consent by the artist to The Cannelton Foundation, Inc. to modify or otherwise manipulate the artwork as needed. No guarantee is made that the artwork will or will not be used in any specific capacity. More than one winner's artwork may be used and/or displayed as seen fit by The Cannelton Foundation, Inc. The contestants shall have no control over any aspect of how the artwork is displayed or utilized before, during or after the celebration.

By participating in the contest, the Entrant is representing and warranting that he/she has read and understood, and agrees to be bound by these rules.
